

## LIVESTOCK ENTRY CONFIRMATION RECEIPT

### WAIVER AND RELEASE OF LIABILITY

ENTRIES WILL NOT BE ACCEPTED WITHOUT SIGNATURES.

I agree to abide by all the rules and regulations in the 2024 LA County Fair Livestock Competition Guides and understand that such rules and regulations are incorporated with and become part of this agreement.

Understanding the potential risk of injury or damage that exists while participating in LA County Fair's Livestock Competition (hereinafter "EVENT") and in consideration for the right to participate in the EVENT, I for myself, my heirs, executors, administrators, assigns, and/or personal representatives (hereinafter collectively "RELEASORS" which shall also include RELEASORS' parent or guardian if RELEASOR is under the age of 18) knowingly and voluntarily enter into this **WAIVER AND RELEASE OF LIABILITY** and hereby waive any and all rights, claims, or causes of action of any kind arising out of my participation in the EVENT.

I further release and forever discharge the Los Angeles County Fair Association, State of California, County of Los Angeles, and City of Pomona their affiliates, managers, members, agents, attorneys, employees, staff, volunteers, heirs, representatives, predecessors, successors, and assigns (hereinafter collectively "RELEASEES") from any and all liability of every kind and character on account of loss, damages, injury to property, or injury to person as a result of my participation in the EVENT.

I agree to defend, indemnify and hold harmless RELEASEES from and against any liability, claim, loss or expense (including reasonable attorneys' and experts' fees) arising out of any injury or damage, which is caused by, arises from, or is in any way connected with my participation in the EVENT, excepting only that caused by the sole active negligence of RELEASEES. RELEASEES shall not be responsible for accidents or losses that may occur to any of the exhibitors of exhibits while participating in the EVENT including traversing the Los Angeles County Fair Association's fairgrounds.

YOUTH: I will complete the Youth for the Quality Care of Animals training required by the State of California. I believe that my participation in the LA County Fair Youth Livestock Program should demonstrate my own ability, knowledge, and skill as a feeder and fitter of livestock. I will do my own work and only accept advice and support from others.

I will not use abusive or questionable techniques in the feeding, fitting, and showing of my animals. I will not resort to fraudulent, illegal, or deceptive practices when fitting the animals for show. I also will not allow my parents, my supervisor, or any other adult to employ such practices to my animals.

#### **I WILL READ AND UNDERSTAND THE RULES OF ALL LIVESTOCK SHOWS IN WHICH I AM A PARTICIPANT.**

I ask that those assisting with my livestock projects (parents/leaders/teachers/agents) not break the rules or make exception on my behalf. I wish for my livestock project to be an example of how to accept what life has to offer—good and bad—and how to live with the outcome.

I realize that I am responsible for:

- The proper care and treatment of my animals.
- The production of wholesome food.

- The development of sound moral character in myself –and others.
